- Each entry must not exceed two (2) minutes in performance time per entry. Deductions will be made for any performance above two (2) minutes.
- AWARDS will be presented at Veterans' Memorial Park at the conclusion of the parade and upon • completion of judging and scoring. Standard parade rules will govern.
- All entries must incorporate the Parade Theme into their entry. •
- All entries must include Holiday Lights. •
- All participants must be clothed, uniformed, costumed or appropriately attired. •
- All entries should have a positive theme which respects diversity, is non-controversial and does not • advocate any political candidate, proposition or position.
- All entries in the parade must be approved by the Parade Committee. Any deviation from the rules must be • approved by the Parade Committee prior to the acceptance of the parade application.
- No entry shall include a Santa Clause.
- The Parade Committee accepts no responsibility for false statements made by applicants or entrants. •
- FORWARD motion must be maintained throughout the parade route. •
- Violations subject to disgualifications. •
- No one under the age of 5 will be permitted to march (without special permission). •
- Entry should carry an identification banner if possible. •
- All entries must be received by 5:00pm on Wednesday, November 27, 2019.
- All entries must have a representative present at the Mandatory Pre-Event Meeting on Tuesday, December 3, 2019 at 6pm; meeting location will be at Coachella Corporate Yard, 53462 Enterprise Way.
- Check-in booth will be **closed at 5:00 p.m.** All units must be checked in by this time.
- Awards that are not picked up will be held for 10 days only. •
- At no time is any unit allowed to hand out or throw anything along the parade route. •
- No sirens, firing of firearms, preaching, or any loud noises, which may interfere, with other units. •
- Parade will start promptly at 6:00 p.m. check-in prior to 5:00 p.m. •
