Upon an application for renewal, the city council may grant, conditionally grant or deny the renewal of the entertainment permit pursuant to this chapter. The city council may renew an entertainment permit for a period up to three years which shall automatically expire unless the permittee shall apply for a renewal pursuant to the procedures for an original permit.

5. Plot Plan Showing:
 - a. Location of property
 - b. Location of floor plan, all streets, alleys, lots, parcels of land, buildings or residences within 300 feet of the exterior boundaries of the property
 - c. Location of vehicle parking areas
6. Please provide a written description on the following items:
 - a. The days and hours during which the entertainment establishment may operate;
 - b. The total peak-hour number of persons including employees and entertainers who are allowed in the entertainment establishment during its operation;
 - c. The necessary traffic control measures including parking monitors and the number of parking spaces required for the entertainment establishment;
 - d. The necessary noise control measures required in the entertainment establishment;
 - e. The measures for the security or safety of the patrons, employees, neighbors and general public of the entertainment establishment including security cameras, steel hardware for doors and the number of security personnel which may be altered by the chief of police; and
 - f. The placement and utilization of hand-held metal detectors at each entrance to the entertainment establishment for the purpose of ascertaining and removal of weapons from each and every person entering the entertainment establishment to the satisfaction of the chief of police.
 - g. A system by which the permittee separately identifies each and every adult in the entertainment establishment so as to distinguish each adult from any and all minors within the entertainment establishment.

8. Information on other businesses owned or previously owned by the Applicant including addresses, website links, and/or copies of business licenses.
9. A document showing that the applicant is the owner of the premises, or an agreement in writing by the owner permitting such use of the premises
10. A statement from applicant's physician verifying that applicant is free of any infectious, contagious or communicable disease and that the applicant is not abusing alcohol or any drug
11. The applicant shall show proof of completion of a course approved by the alcohol beverage control board on the laws and procedures pertaining to service of liquor.
