- 6. Do existing handrails anchors need tightening or replacement?
 - a. Replacement.
- 7. Number of pool lights?
 - a. 7
- 8. Dimensions of drain covers
 - a. 2 x2; 2 total
- 9. Item 8 "Replace all step entries . . "
 - a. This is referring to replastering of steps and existing tiles be removed and replaced with new like tiles.
 - b. Replacement tile is 1 square inch.
- 10. Current manufacturer and model of pump.
 - a. Baldor Reliance Industrial Motor; Motor Type 3733M; HP is 10; Volts 208-230/460; RPM 1765.
- 11. Quantity of return covers noted in bid item 12.
 - a. 16
- 12. Chlorinator system and controller manufacturer.

 - a. Confirmed.
- 18. Do both pool filters need to be replaced?
 - a. Yes, filters for both pools must be replaced; total filters 3.
- 19. Exhibit A for agreement.
 - a. Will reflect the Special Condition listed in RFP.
- 20. Exhibit B for agreement.
 - a. Will reflect Item 9 *Instructions to Bidders*: The term of the contract will be for a Thirty Days from the date the Notice to Proceed is issued.
- 21. Please replace mention of tree trimming on pages 25 with *pool construction experience*. There is not tree trimming services as a function of this RFP.
- 22. Section 3.2.7.1 of template agreement, page 31 of RFP will be amended when executed to reference \$300.00 per calendar day.
