OWNER-BUILDER DECLARATION

I, hereby affirm under penalty of perjury that I am exempt from the Contractor's License Law for the following reason (Sec. 703.1.5, Business and Professions Code: Any city or county which requires a permit to construct, alter, improve, demolish or repair any structure, prior to its issuance, also requires the applicant for such permit to file a signed statement that he or she is licensed pursuant to the provisions of the Contractor's License Law (Chapter 9 (commencing with Section 7000) of Division 3 of the Business and Professions Code) or that he or she is exempt there from the basis for the alleged exemption. Any violation of Section 7031.5 by any applicant for a permit subjects the applicant to a civil penalty of not more than five hundred dollars (\$500).):

POOL DEMOLITION PROCEDURES AND PERMITTING

To legally demolish a residential pool structure in the City of Coachella an applicant must adhere to the following procedures:

- 1) Obtain a permit for the demolition of the pool at the City Building Department.
- 2) Pump out all chemically treated water to storm drainage location, do not use this water for backfill.
- 3) Break a 4x4 ft. square hole at the bottom of the deep end of the pool structure or 6 1 ft. square holes in the deep end.
- 4) Break up and remove top 2 ft. of pool wall measured from the finish grade down.
- 5) Fill pool shell with gravel, sand or clean native material that is free of clay up to surrounding finish grade level.
- 6) Remove all wiring and breakers serving pool electrical system and cap conduit on both ends.
- 7) Remove fuel gas piping on both ends of gas conduit including cutting off threads on both sides of conduit.
- 8) Remove water line connection to pool and cap piping at point of connection.
- 9) Repair lot drainage so that new grade has a slope of 1% minimum to approved drainage location.
- 10) Remove all equipment and equipment pad.
- 11) Obtain inspection to verify all of the above items have been completed, these inspections must occur during the process to verify holes and wall removal prior to burial.
